BACKGROUND

Local Government in Western Australia is responsible for managing \$13 billion worth of infrastructure assets on behalf of their communities. That's a significant and very important responsibility that elected members and staff are undertaking for the current and future generations of people who rely on this vital infrastructure for their well-being.

The cost of building, operating and maintaining infrastructure means great care must be taken in planning and prioritising what the community needs. Decisions made today, both good and bad, will affect generations to come and Councils have both legal and ethical obligations for effectively managing assets on behalf of their community.

The WA Local Government Association, Local Government Managers Australia (WA Division Inc), Institute of Public Works Engineers Australia (WA Division) and the Department of Local Government and Regional Development have recognised that many Councils are looking for assistance in planning and managing their infrastructure assets. On a partnership basis and in conjunction with a number of Councils, the WA Asset Management Improvement (WAAMI) Program has been developed.

The concept for the WAAMI Program comes from the recognition that the Local Government sector as a whole is facing the challenges of asset management and there is a need for a common approach to this issue. The WAAMI Program is aimed at achieving a whole of organisation commitment to improving asset management, from staff through to the elected members and Council.

The benefits of the WAAMI Program that will be realised for Local Government include:

- Increasing the understanding of ongoing financial demands of infrastructure provision decisions incorporating concepts such as whole-of-life costing for infrastructure assets.
- A statewide and consistent approach to infrastructure asset management.
- Implementing a 'best practice' approach to the management of infrastructure assets.
- Defining a systemic process for Local Government to follow when dealing with infrastructure and asset management issues.

- Clarifying the roles and responsibilities of each party during the development and implementation of the infrastructure asset management framework.
- Enhanced co-operation and information/resource sharing.
- Improving the quality of infrastructure asset management communication amongst all the parties and with Councils.

Councillors, as elected representatives of the community, are the custodians of a sizeable investment in infrastructure by past, present and future generations. Understanding the long-term implications of asset management decisions is essential in providing a cost effective, sustainable service and an equitable distribution of the cost burden across generations.

The roles of the custodian are:

- To ensure that the legal obligations of the Council are met.
- To represent the community as the asset owners.
- To ensure the asset/service (functionality and presentation) is maintained for future generations at an equitable cost.

It is the responsibility of Council staff to provide accurate, well founded technical and professional asset management advice so that Elected Members can make informed decisions on behalf of the Community they represent.

There is a growing national and state concern that Local Government infrastructure assets are being allowed to deteriorate to a point where they will become an unreasonable burden to future generations. To ensure this is avoided, it is necessary to promote sound and sustainable management of Local Government infrastructure assets both now and into the future.

This will require the preparation of long term asset management plans, in consultation with Council, staff and the Community, and the allocation of adequate funding to cater for the loss of asset service potential, ie depreciation or asset deterioration.

Long term asset management planning is necessary to ensure:

- Good corporate governance.
- Sound long term financial management.
- Sustainable, equitable and affordable service delivery.
- Management of risk associated with asset function and presentation.
- Effective maintenance of asset function, asset presentation and capacity to deliver services.
- Smooth funding provision to manage the loss of asset service potential over time.

The law of negligence is a fault-based system whereby a person (or entity) that carelessly causes injury or loss to another person can be held responsible and should compensate that person. The High Court has recently ruled that this should also apply to an authority (Local Government) that does not maintain its assets to an appropriate standard. The recent loss of nonfeasance immunity has served to increase the profile of asset management within Local Government.

The High Court decision has prompted the need for Councils to demonstrate responsible stewardship of their assets – "know what Council owns, ensure that Council assets continue to function "as built" and ensure asset maintenance programs are based on proactive inspections with response programs focused on affordable maintenance "Levels of Service".

The Western Australian Government has partially restored "non feasance" through the introduction of the Civil Liability Act which provides a public policy defence.

It is best practice for Councils to ensure that they achieve at least a minimum or reasonable standard of asset management to determine the assets renewal funding gap, while at the same time, ensuring infrastructure sustainability and good governance.

The Western Australian Asset Management Improvement Programme "WAAMI" will assist Councils in working towards achieving this minimum standard.

Both metropolitan and rural local governments had been encouraged to band together to take advantage of resource sharing opportunities and in particular to consider regional applications to the Department of Local Government and Regional Development's Connecting Local Governments grant funding.

On the 30th October, 2008, local governments including Menzies, Laverton, Wiluna and Leonora met with Ms Michelle Mackenzie, Executive Manager, Infrastructure, WA Local Government Association to discuss the WAAMI Program and in particular, ideas on implementing asset management.

Each local government advised that a Council resolution would be required before proceeding further with the proposal.

STATUTORY ENVIRONMENT

In accordance with Section 3.1 (1) of the Local Government Act 1995 being the general function of a local government to provide for the good government of persons in its district.

POLICY IMPLICATIONS

There are no policy implications resulting from the recommendations of this report.

FINANCIAL IMPLICATIONS

The WAAMI Framework document provides a comprehensive outline of the rollout process for the WAAMI Program. The total cost (excluding GST) of this comprehensive two (2) year program, incorporating four (4) visits, is \$14,900.00 or \$7,450.00/per annum which equates to \$3,725.00 per visits.

This cost is not included in the current budget. Unauthorised expenditure will need to be authorised if Council resolves to proceed with the program.

STRATEGIC IMPLICATIONS

There are a number of basic steps that form the foundation for improving Local Government Asset Management. As a minimum, Council needs to have an Asset Management Policy/Purpose and Asset Management Practice Improvement Strategy to provide direction and guidance for asset management planning. Asset Management planning translates broad strategic goals to specific goals and objectives, generally through the development of Asset Management Plans, which provide more detail and long-term projections. Operations comprise detailed action plans and information with a one to three year outlook to provide for the delivery of the defined levels of service.

Operations collect and record data related to asset activities, feed this into information systems and ultimately report on asset condition and performance. Analysis of this information provides the necessary knowledge, which adds to the wisdom of the organisation and assists in providing future policy/purpose direction.

BACKGROUND

Geographical names in Western Australia are an essential reference system for transportation and communication and are an important element of our culture. Clear, unambiguous names for populated places, roads and physical features are essential for correct reference in resource development and planning and standard forms of names are important elements of reliable maps and charts. The orderly process of designating names for landscape and seascape phenomena permits the State to exercise its prerogative in managing and protecting this aspect of our culture and heritage.

The Geographic Names Committee, originally the Nomenclature Advisory Committee, was appointed as an advisory committee to the Minister for Lands in 1936. Essentially, it performs a similar role today as it did in 1936, in providing advice to the minister on geographical name issues. The name of the Committee was changed in 1987 and the representation was revised in 1987 and 2002.

The primary task of the Committee is to develop rules and guidelines for approval by the Minister. Changing attitudes and perceptions and the pressures of urban growth have led to the revision and updates of guidelines. The guidelines on the naming of parks and reserves and roads have been significantly changed following consultation with local government.

Of all the Committee's guidelines, that of restricting the approval of names honouring living persons is the most contentious. Although this policy may seem unduly restrictive, it prevents the naming of features on the basis of self-recognition or through exerting inappropriate influence. Because place names make inexpensive, long –lasting and prominent memorials, the Committee in the main prefers to base assessments on the lifetime achievements of a person.

The Secretary of the Committee represents the State on a national consultative committee that meets annually to address issues of common interest to all states and territories and some guidelines adopted now reflect a national approach.

The Geographic Names Committee is served by a Secretariat provided by the Information Services Division of LANDGATE. The secretariat serves the needs of the real estate, Local Government and mapping industries for names and maintains a computer database "GEONOMA" that holds essential information on all named roads and places in the State.

Responsibility for the naming of roads, features, townsites and places in Western Australia resides with the Minister for Land Information. The Geographic Names Committee was established by the Minister and represents many different points of

view, from local communities to professional institutions and government agencies within Western Australia. It provides an inexpensive mechanism to make democratic naming decisions for the State Government.

Survey documents require endorsed road names before the survey can be approved. To facilitate the early release of titles, the developer or their agent should be prompt in lodging a concept plan and a proposal for road names with the Secretary, Geographic Names Committee. Proposals should conform with the 'Road Naming Guidelines' and it is advisable to supply the relevant local government with a copy of the proposal. Following agreement between the Committee and the local government, the names will be approved and all interested parties advised.

The new industrial subdivision includes two roads which at this point in time remain unnamed;

- (I) that section of road between Kurrajong and Tower Streets (see drawing)
- (II) that section of road between Kurrajong Street and the rail crossing near the former State Battery (see drawing)

Naming of roads can be controversial.

In 1990 the following road names were submitted by the Shire of Leonora to the Geographic Names Committee for approval which were all subsequently granted.

- Fitzgerald Drive
- Walton Street
- Rowe Court
- Edquist Street
- Mackinnon Court
- Cleland Court
- Hadfield Place
- James Place
- Snell Street
- Bell Court

The above road names will eventually be shown on all relevant plans, subject to the lodgement of the relevant survey documents.

Some are already shown on plans where a residential sub-division has been undertaken. The remainder will appear as further residential land is released.

The names mentioned above have one thing in common in that the persons were all previous Shire Presidents/Chairman or Mayors of Leonora.

I am proposing that the two roads in the industrial sub-division also be named after former local government dignitaries.

- (I) That section of road between Kurrajong and Tower Streets to be known as Millar Street named after Leonora Shire Chairman R.B. Millar 1927 to 1938.
- (II) That section of road between Kurrajong Street and the rail crossing near the former State Battery to be known as Cayzer Street named after Leonora Shire Chairman C.W. Cayzer 1947 to 1949.

BACKGROUND

Stage three of the industrial land sub-division is the acquisition of Leonora Lots 971, 1354, 1355 and 944 on Deposited Plans 184084, 30929 and 175640. The development when complete will permit the release of 14 lots for industrial purposes ranging in size from 2400m² to 8000m². Prior to release, additional road works are required namely;

- (I) extension of Court Street to sealed standard
- (II)extension of Kurrajong Street to sealed standard
- (III) construction and sealing of new road proposed to be named CAYZER Street,
- (IV) construction and sealing of new road proposed to be named MILLAR Street.

It is necessary that the link between Tower and Kurrajong Streets (proposed to be named Millar Street) cross the right of way behind those residential properties facing Tower Street. As a consequence it is necessary that the section of the right of way under the road be closed.

The right of way is a gazetted public thoroughfare falling within the Land Administration Act 1997 definition of a "road" and is under the care, control and management of the Shire pursuant to Section 55 of the Land Administration Act.

The Water Corporation maintain a public water main in the right of way. Consultation with that Authority in regards suitable arrangements will be necessary. No sewer line exists within the right of way.

STATUTORY ENVIRONMENT

In accordance with Section 55 (2) and 58 of the Land Administration Act and Section 3.52 (2) of the Local Government Act 1995.

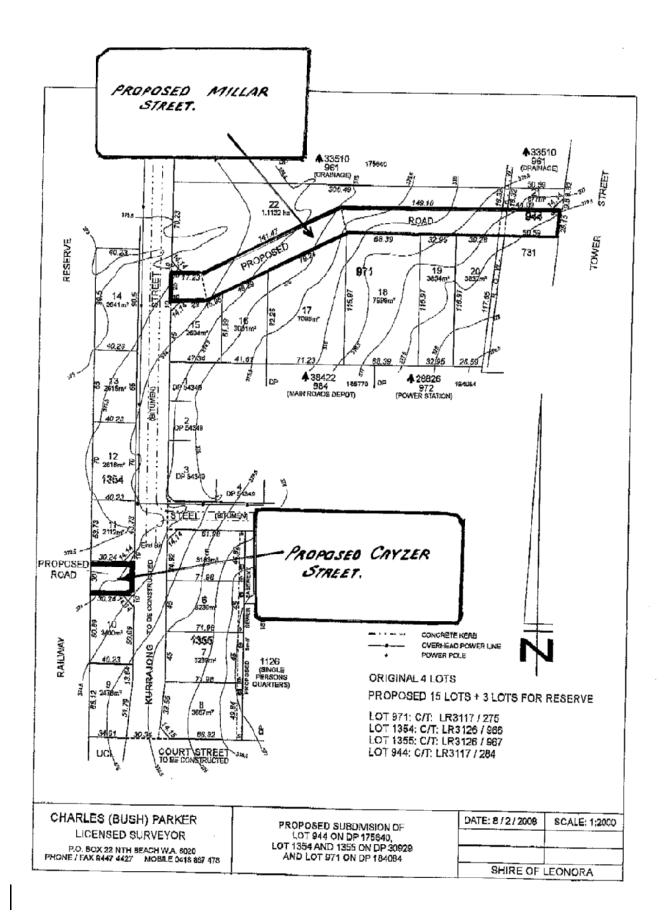

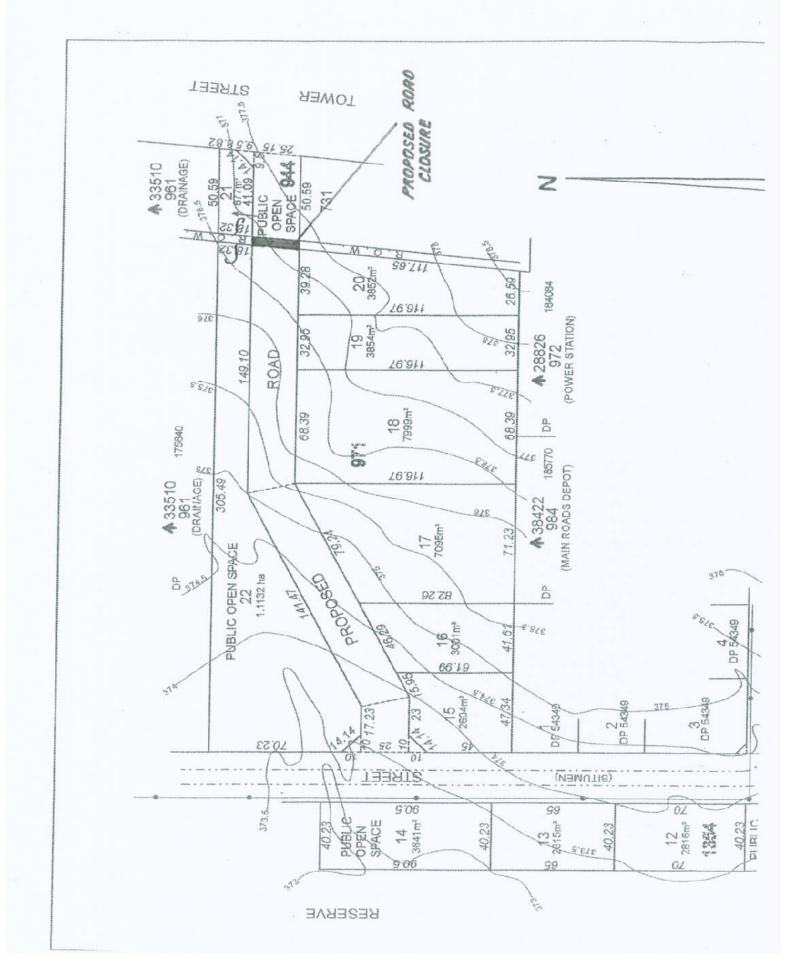

BACKGROUND

DATE:

Council at its meeting on the 21st October, 2008 resolved that subject to obtaining approval from Service agencies, that a request be made to the Minister for Planning and Infrastructure to close that portion of the right of way between the south west corner of Leonora Lot 725 to points intersecting with Drainage Reserve 33510 and the right of way at the rear of Rochester Street Lots 877, 1333, 879, 880, 81 and 82, and that both areas of unallocated land be made subject of reservation for the purpose of Public Utility Services and Access with the Shire of Leonora retaining management control.

STATUTORY ENVIRONMENT

Any road closure must comply with Section 58 of the Land Administration Act and regulation 9 of the Land Administration Regulations 1998.

Section 58 (3) of the Land Administration Act states "a local government must not resolve to make a request to the Minister to close a road until a period of 35 days has elapsed from the publication in a newspaper circulating in its district of notice of motion for that resolution, and that the local government has considered any objections made to it within that period concerning the proposals set out in that notice'.

The "Road Closure" notice was published in the Kalgoorlie Miner on the 28th October, 2008. No objections or submissions were received within the 35 day advertising period which expired on the 1st December, 2008.
